Review of Minutes: Second Month

Finance Committee - Pat Johnson

Fund balance in the "All Funds Report" remains the same as last month.

Contribution income so far this year is \$1702.14 (10.9% of the budgeted amount).

With rental income, 14.2% of this year's budget has been met to date. Insurance costs this year will be \$2609, which is a bit over what has been budgeted. Payroll expenses reflect 2010 costs, expended in 2011.

Friends accepted the Treasurer's Report as given.

Kitti clarified that Quaker outreach and community contributions would be listed as line items in future finance reports.

Spiritual Enrichment Committee - Steve Livingston

Spiritual Enrichment is working to plan the upcoming retreat with Dan Snyder, whose organization has been coordinated by Margaret. Registration for the retreat should be completed by 17 April (\$25 suggested donation, based on 20 anticipated participants). To date, 9 people have signed up (8 paid), and 4 more plan to come, for a total of 13 planned participants. If you are paying by check, be sure to write "retreat" in the memo line so that it is clear that these monies are not contributions to AFM. The committee is contacting folks on our roster who might not be aware of this retreat, to make sure they know of this opportunity. The committee hopes that the retreat pays for itself (20 or more participants), but if not, the committee might ask for funds at a future business meeting.
