Christi Estes (SAYMA Clerk) has requested up to 8 places for Friends to sleep during this retreat. SAYMA asks for AFM to send at least 2 representatives to this retreat. Pat Johnson, Gita Larsen, and Jim Cavener offered space for retreat attendees. There is also space at the Meetinghouse.

Finance Committee Report

As of the end of August, AFM has brought in \$12404.61 total income (\$8384.24 in donations, the rest in rental income) so far this year, raising 61.74% of the 2012 budget. Adrienne noted that some groups

used our space for multi-day events, which contributed significantly to this income. We have spent 83% of our total budget so far. The Finance Committee is looking at the level of scholarship funds allotted to date. It appears that we have a balance of \$123.00. Peace and Earth Committee has decided to contribute \$100.00 to the fund for Stephanie Gossett's preschool project in Swaziland. The SAYMA check for our annual dues will be \$2680, and has not yet been sent.

Susan Oehler will be helping the Finance Committee with bookkeeping (using QuickBooks). Pat Johnson will be out of town for the rest of September but will be back for the next Business Meeting. If checks need to be cut in the meanwhile, contact Adrienne.

Katherine Kowal (Nominating Committee Clerk) requested that committee assignments and recruitment go through their committee. Nominating will consider the two candidates above, and one additional one, to fill the vacant Bookkeeping position. [ Note added later. It was later decided that the Bookkeeping position was not a matter for Nominating Committee, but should be left up to Finance Committee to fill]

#### Stephanie Gossett's Request for Support for Preschool in Swaziland

Stephanie only needs \$257.77 more to make her Peace Corps grant request. This grant will train parents and teachers to support preschoolers' education. The Swaziland village has already contributed some money to this project, as have the Peace Corps administrators.

One Friend suggested that these monies might come from the Alice Brown fund; we noted that her fund is administered through Ministry & Council. A Friend noted that the Alice Brown monies were intended to be used directly within the Meeting, and Adrienne agreed to look up information about the fund to ensure that Alice Brown's wishes were being met. A Friend noted that, upon graduating from college, Alice Brown spent time teaching in Africa, so this might be a good use of these monies. Another Friend noted that the Al Dupree Memorial Fund (\$295) might be an appropriate source of support for Stephanie's project. The College-Age Friends Support Fund could also be used. Kitti said that we could consider using Al Dupree's money as something like our contribution to the Kabarak Call for Peace and Ecojustice.

Joy noted that Stephanie is working on a second grant to empower Swazi women, and she might request additional Meeting funds in the future. A Friend was concerned that requests for funds for such efforts might be ongoing. Another Friend noted that the needs in Africa were profound, and that our Meeting should be mindful of how we might meet such needs. Kitti said that this would be discussed later, and that the Spiritual Enrichment Committee planned a follow-up discussion about our Kabarak Call leadings.

**Minute: Friends approved the use of Al Dupree funds to support Stephanie's request.**

A Friend thanked Pat for the financial clarity that she brought to this discussion.
