Those of us known as ‘activists’ have sometimes been hurt by the written or spoken implication that we must be spending too little time on our spiritual contemplative lives. I do know many atheists who are active to improve the lot of humankind; but for those of us who are Friends, our attendance at meeting for worship and our silent prayerful times are what make our outer activity viable and effective - if it is effective.

I have similarly seen quieter Friends hurt by the implication that they do not care enough, because they are not seen to be ‘politically active’. Some worry unnecessarily that they may be doing things of a ‘less important’ nature, as if to be seen doing things by the eyes of the world is the same thing as to be seen doing things by the eyes of God. . . I suggest that we refrain from judging each other or belittling what each is doing; and that we should not feel belittled. We cannot know the prayers that others make or do not make in their own times of silent aloneness. We cannot know the letters others may be writing to governments, similarly. . . We were all made differently, in order to perform different tasks. Let us rejoice in our differences.

Treasurer’s Report

Apologies from the Finance Committee, as the report suffered from technical difficulties. Funds have been entered into the computer but it was not possible to print the report. A review of our bank accounts found that the money appears to be safe. We own no stock, and our account seems secure at this point. We are about \$5500 behind in receipt of funds, about 1/2 way to where we should be to meet the budget. It was reported that Religious Education was over-budget by about \$200. The RE Committee requested itemization of expenditures last month. Once again a Friend expressed concern that the grill was billed to RE budget instead of to another budget line item. A Friend

reminded us that the budget is a guideline.

##### **Nomination Committee Report**

##### **Peace and Earth Report, Tenth Month 12, 2008**

At the Ninth Month, 2008, meeting of the Peace and Earth Committee, we decided Margaret Normile will manage the emails we send around, which has been the main way lately that we have conducted business. She will also summarize our activities for Business Meeting, which Kitti Reynolds will continue to report, with Pat Johnson as a backup.

Kitti will continue to sign for Peace and Earth budget requests, with Pat as a backup. Susan Oehler will become our recording clerk.

Kitti will continue to collect Peace and Earth mail, and decide what needs to be brought to the attention of the committee.

Kitti and Margaret will be co-clerks, so Peace and Earth emails can be sent to both or either of us.

Action Item: Peace and Earth is asking Business Meeting about having 20-30 college students stay in our Meetinghouse on Saturday night, November 1<sup>st</sup>. Adrienne Weir knows a representative for this group and is willing to be a Meeting presence there that night. Susan Oehler volunteered to be her backup. The students are coming to the UNCA campus for workshops on clean energy and sustainability. Kitti Reynolds is familiar with the student environmental organization on campus, which is organizing the meeting Nov. 1<sup>st</sup> and 2<sup>nd</sup> and can vouch for their concern for the environment. I have already informed Derek, the UNCA student helping to organize this, that students could only use the Meetinghouse for sleeping (come late and leave early) and that no alcohol, smoking, or illegal drugs will be tolerated.

Discussion: This will be contingent on availability of the meetinghouse per Gary Briggs, the calendar manager. However, having a group staying in the meetinghouse may need

meeting approval since we have had problems in the past. **Meeting was in favor of having the group of students stay, as long as there are 2 adult members of the meeting community staying with them. We will ask that the group make a donation rather than being charged a fee if the fee is a hardship for them. Approved.**
