**Asheville Friends Meeting**  
Eleventh Month 11, 2018

Meeting began with a period of silent worship from which clerk, Robin Wells, read the following:

I want to bring into the room, the spirit of our Meeting retreat. A common thread at the retreat was a strong feeling of connection with each other. As we were led to share deeply, there emerged a longing for even better connection among us--during our time at Meeting and during the time between first days. In the months to come, I hope we will explore how best to do this. For now, let's take a moment to sit in the Light that connects us all.

The Meeting accepted the agenda.

**Minute #1: Friends approved the 10th month minutes of the Meeting for Business**

Announcements

1. Our Meeting's first day school is exploring the Quaker testimonies this year. The month of October was dedicated to the peace testimony and the month of November is based on the integrity testimony. The hope is that the whole Meeting can also do this work with the Queries.
2. We have had an email exchange with Sharon S. She is requesting mediation. Ministry and Counsel is working on this.
3. Since the Recording Clerk will be out of town when the next Meeting for Business occurs, Kitty Reynolds, agreed to function as the Recording Clerk that day.
4. The Clerk announced an issue of concern regarding an email sent by someone in Asheville Friends Meeting to an adult leader in the SAYF Program regarding their use of materials and decision-making process. The Clerk expressed her concern about this email and indicated that an email/letter will be sent to the SAYF leader indicating the Meeting trusts the group's decision making process, supports their work and welcomes the return of group.

**Treasurer's Report** – Satchel Loftis, our treasurer, explained the various funds the Meeting has and stated that his report will cover the Operating Fund. At this time the Meeting is \$10,000 behind what was brought in by this time last year, but since historically, much of the anticipated income comes in the last two months of the year, he is not yet worried. If this money does come in, as anticipated, there will be no problems.

Satchel reviewed for the Business Meeting the various line items of the budget. When questioned, explained was the large unspent fund of the Racial Justice Committee and their lack of control of when they can spend the training money. He also said that most of our budget is spent on some form of outreach. He reiterated that increased income will be needed over 11<sup>th</sup> and 12<sup>th</sup> months to make budget. He plans to close out the 2018 budget year by mid-January and asks that expenses for reimbursement be submitted to him by mid-December.

Satchel indicated that the \$6000 in the Meeting House Improvement Fund is available for the needed replacement of stairs.

All of the Meeting House Retreat expenses are not available at this time given the Retreat was only a week ago.

**Finance Committee Report** – Committees were reminded that budget requests should be submitted by 11<sup>th</sup> Month 30.

**Request for Membership** - Robin Wells reported that Annika Peacock has requested membership in the Religious Society of Friends through Asheville Friends Meeting. Her letter to the Clerk requesting membership was read to the Meeting for Business; a Clearness Committee will be formed.

The Clerk explained that the function of the Clearness Committee was to ask questions and help the applicant discern whether she/he is clear to join. Ministry and Counsel Committee then makes a presentation and recommendation at a future Meeting for Business. The decision will then be held over for a month.

**Long-Range Planning Committee** - Patti Hughes reviewed the minute regarding the Long Range Planning Committee that was held over from last month.

Friends approved the following minute:

**Minute 2: The Long-Range Planning and Visioning committee is to be a standing committee of the meeting. This committee would keep in mind an overall ethic of sustainability with the purpose of creating a holistic long-view plan to help the Meeting make thoughtful, Spirit-led decisions. The work of the committee would create a connection between all aspects of meeting life. It would offer an ongoing overview of the Meeting's progress according to a plan created by members of the committee and presented to Meeting for Worship with Attention to Business. Each of the standing**

**committees would be offered a place on the committee. There may also be some at-large members.**

Nominating Committee - Kitti Reynolds

Nominating committee asks Friends for approval of Pat Campbell for Recording Clerk and to accept her request to step down from the Finance Committee

**Minute #3: The Meeting for Business approved Pat Campbell as the Recording Clerk and accepted her stepping down from the Finance Committee.**

Retreat Committee - Katherine Kowal

The AFM retreat at Montreat Conference Center was a great success. Twenty adults and three children attended all or part of the weekend. We cooked together, washed dishes together, sang together, worshiped together, and hiked together. The operative word here is "together." We laughed a lot and sometimes cried. We talked about the people whose love and faith in us had made a difference and where we had made a difference in the lives of others. We explored the meaning of community and what gifts we each had to bring to our AFM community. At our closing worship nearly everyone expressed gratitude for this experience as well as gratitude and renewed appreciation for the value of our Quaker community.

On the financial side we collected \$2,305. We spent \$2625.

We overspent by \$323. However, we had \$428 in the Retreat account from previous years so we still have a balance in that account for "seed money" for the next retreat.

**Minute #4 The Meeting minuted its appreciation to the Retreat Planning Committee for their hard work on a very successful retreat.**

Library Committee - Pat Campbell

The library has finished purging (with minor exceptions) old, outdated or inappropriate books from the library and beginning to rearrange and catalogue the remaining collection. We are planning and prioritizing the next steps that need attention and have submitted to the finance committee the Library Committee's request for next year's budget. We are also considering working on a policy regarding donations.

Ad-Hoc Planning Committee for the Spring SAYMA Representative Meeting in Asheville on 3/16/19 - Robin Wells said that AFM, in hosting this event, will need a planning committee for hospitality and food. Steve Livingston, Kitty Reynolds, Pat Campbell, and 2 (undetermined) members of the Hospitality Committee will be on this Committee. Steve Livingston volunteered to be the Clerk. This Committee will need to be active by 1<sup>st</sup> Month. Friends were asked to think about whether they might host someone for one or two nights.

SAYMA Queries - Edie Patrick

On tenth month 21, 2018, during the second hour, perhaps eight or nine of us went through the proposed queries for the new SAYMA Faith & Practice. Most of the suggested changes were made at that session; one person emailed suggestions. Any changes proposed by our meeting must be approved at our business meeting. Only approved changes will be sent on to the SAYMA query committee.

Today these suggestions will be looked at and tentatively approved as we are able, although final approval by the Business Meeting will occur by 1<sup>st</sup> Month 2019 Business Meeting.

The revised Query suggestions will be attached at the end of this document.

Duties of the Clerk for the AFM Manual - Patti Hughes again presented the draft of the Meeting Clerk's duties, which had been held over from the previous Meeting for Business.

### **DUTIES OF THE CLERK (DRAFT)**

First let us define what the clerk is NOT. The clerk is not a spiritual leader. The clerk is not a pastor. The clerk is not a therapist for the meeting.

1. The primary duty of the clerk is to ensure that the business of the meeting is conducted "after the manner of Friends." Normally, the clerk will preside over all regular meetings for worship with attention to business, called meetings, and threshing sessions although he/she may delegate another person to do so.

- a) The clerk sets the agenda for the meeting.
- b) The clerk ensures a free and open discussion of the matter at hand by calling on individuals to maintain order.
- c) The clerk ensures that the discussion is carried out in a spirit of worship
- d) The clerk tests the sense of the Meeting by suggesting wording of a minute.
- e) The clerk may offer "test sentences" to see if members are in unity around the sentences.
- f) In the case further action is required, the clerk appoints someone to carry out the action
- g) The clerk is normally concerned with process rather than outcome of the discussion. In those rare instances when the clerk is led to speak out of concern for an outcome, someone else will be appointed to clerk the discussion and the clerk will become a participant for the duration of the discussion.

2. When the Meeting for Business has agreed on a certain action, the clerk acts as "the voice of the meeting" in sharing this stand with other parties.

3. The clerk represents Asheville Friends Meeting at public gatherings of faith communities or appoints someone.
4. The clerk is an ex-officio member of all committees and may attend their meetings. The Clerk is a member of Ministry and Counsel and of the Board of Directors of Asheville Friends Meeting.
5. The clerk supports those in positions of responsibility and committees carrying out their task.
6. The clerk writes minutes for traveling and sojourning Friends as well as letters of transfer of membership as requested.

This section was held over until the next Business Meeting so more Friends could review them.

We closed with a moment of silence to meet again as way opens in twelfth month, 2018.

Asheville Friends Meeting, at its 11th Month Meeting for Business, reviewed the proposed changes in the Queries, striking out language we recommend for deletion and highlighting in yellow the approved changes we recommend for inclusion to the SAYMA Committee working on the Queries.

**SAYMA Committee to Revise the Guide to Our Faith and Practice**

**Revised Queries (Draft B)**

**As of the end of September 22, 2018**

*“Queries are understood to have three distinct values: the personal value, as we find the answers in ourselves; the interpretive value, by which the progressive application of our religious principles to life is disclosed; and the corporate value, by which the state or the Society can be appraised. At the reading of them, let us search our own hearts in the Light of the Holy Spirit and carefully ponder these questions for our personal answer.”*

Faith and Practice, Philadelphia Yearly Meeting (1935)

“Quakers use queries for personal reflection, self-examination, or spirited discussion.

American Friends Service Committee “An Introduction to Quaker Testimonies (2011)

**A: Queries for Monthly and Yearly Meetings:**

1. \* In our Meeting for Worship, in what ways are both silent and vocal ministry rooted in *a shared experience of the Light? During meeting for worship, do we search for guidance from the Light? Do we begin silent worship and stay centered despite distractions?*
2. \* *How can I build community through my thoughts and actions regarding being on time to Meeting for Worship?*
3. \*How does our meeting remain in a spirit of worship when conducting business? How can we in Meeting for Business open ourselves to differing views, search for a sense of the meeting, and be guided toward resolution in the Light?
4. \*How can we each use our individual gifts in the work of maintaining our meeting? In what ways can we honor the wide range of contributions from individual Friends to the meeting? How do we help Friends recognize their own gifts?
5. \*How do we build community through monthly and yearly meetings for fellowship, service,

2. \* Do I hold in the Light the responsibility to share my views even though I perceive I may be a minority of one? ~~Can I stand aside to allow the meeting to go forward even though I am not in full agreement?~~ How do I discern when to stand in the way and when to stand aside?

3. \* How have my unspoken assumptions about individuals or groups of people caused them pain? How has this awareness changed my behavior?
4. \* What yearly meeting or monthly meeting responsibilities are mine to do?
5. \* When I see Friends engage in actions or words which seem inconsistent with the testimonies of the Religious Society of Friends, how do I season my reaction to be sure it does not come from lack of understanding or unrecognized prejudice? How do I respond?
6. \* What are some of the distractions that keep me from the right ordering of my life?

6. In what ways do you use your voices and express your opinions? \*When do you reevaluate your perspective? (SAYF: Please consider changing “opinions” to “views” as the original word “perspectives” can include facts and not just “opinions”)
7. How can we be supportive of each other’s identity and growth?
8. (Moved to be the 2nd sentence in number 6.)
9. How do you remain grounded in a materialistic society?
10. How do you reconcile simplicity and self-expression?
11. How do you apply Quaker values to your social media presence?
12. How does your energy change as you enter adulthood?
13. What is the Light? Where do you find that in your life?
14. How do you identify as Quaker, and how do you explain that to your peers?
15. To whom do you extend your compassion?

We want to be sure the Young Friends are intentionally choosing their pronouns. Only 2 of the 15 queries use the first person. More than one in the Asheville discussion preferred "I/we" to "you." One said that the use of "you" is loaded with separation, the "other."
