#### Request for Help Follow Up: Ellie Cox & Debra Rice

#### From Ellie:

I have just had a very interesting phone conversation with Storme Smith about his phone request for information about help for a prisoner.

The call is legitimate! I am attaching a copy of the Contributors page from another publication of The Tryon Daily Bulletin, called Live in our Foothills. Storme (silent "e") is freelance writer who often writes for the Tryon Daily Bulletin and Foothills, and also has a book business. He contacted AFM on the advice of a woman, Corrine Gherwin, who is also a writer, living in Saluda, with whom my husband Bob worked in Brevard, while we were both living there, volunteering at the Dispute Settlement Center. Corrine knew that some Friends were interested in prison reform and visiting, and suggested Storme get in touch with us.

Storme will be emailing you with more information about Alford Jones, the prisoner. I took some notes, however, it is probably best you get the information directly from him. Alford's wife, Miss Linda has worked at the Green River Plantation (a Polk County former plantation enslaving several Africans [or descendants thereof] and now a bed & breakfast and event center) for many years and is a respected woman. Storme said she has lots of recorded details on her computer, so there is verification of Alford helping other prisoners to get early release. Her thought is that her husband is being punished for those activities.

I don't know what the next step should be, maybe running Storme's information by Debra or Adrianne. I am sure you will be led how to proceed. I am planning to suggest that Storme look on the Equal Justice Initiative website of Brian Stevenson to see if they could be of any help or direct him to someone appropriate to work with the Scotland Correctional Institution in Laurinburg, NC, where Alford is now.

Thanks for taking this request of Storme's to the next level.

Debra says we need more information about the crime and parole status. She asked for this information from Storme and if there could be a chaplain contact. She understands all prisons are woefully understaffed. NC legislators just passed a law relating to geriatric prisoners. Could this apply to Alford? Depending on the severity of his crime there may not be anything that can be done. A Friend expressed his gratitude that members of the Meeting are following up on this. Another Friend suggested we contact Nicole Nickle to see if she knows anything that can be done.

### Painting the Meetingroom:

As we discussed last month, Art Mandler of the Zen Center has offered to paint our Meetingroom. This helps us immensely, as it has needed repainting for several years. Art estimates that the preparation and painting will take about three days. He does not want to be paid for this work, but thinks the Zen Center would really appreciate having their rent lowered a few hundred dollars in the coming months. We would like to recommend that we reduce the rent for the Zen Center by \$300 one time and move this same amount of money from the Meetinghouse Improvement Fund (MHIF) to the regular operating budget to cover the reduction. The painting will begin next week.

Does Meeting approve a one time reduction in rent as described above? A Friend asked why only \$300? He feels an urgency to make that amount larger. He suggests twice that much. A Friend pointed out that the painting is meant as a gift. She didn't think that valuing the monetary worth of the gift was appropriate. A Friend pointed out we would need to clear out the room for the painter. A Friend felt there was Spirit leading us to generosity and the gift is not to the painter but to the Zen group. A Friend appreciated the Friend's comment that this not be transactional and suggested we commit ourselves to an additional amount of money, maybe \$500, to the Zen Center at the end of the year. Another Friend pointed out that the Zen Center is struggling now. A Friend suggested we commit the \$300 now and sit with the idea of paying more to Zen Center later. A Friend suggested we consider other ways of sharing our commonalities with the Zen Group.

<u>Minute #4:</u> Meeting approved reducing the rent of the Zen Center one time by \$300 because we are grateful for this painting work and value the Zen Center's use of our property as kindred

spirits. The Treasurer will transfer money from the MHIF to the general fund. We will sit with giving a later gift of money to the Zen Center.

Adrienne, Barbara and Pat volunteered to move stuff out of the Meeting room before the painting on either the 18th or 19th.

### Gun Surrender Event on June 8th

Meeting approved sponsorship of this June 8, 2024 event by \$500. Individuals in Meeting are invited to contribute money toward the gift cards given to those who surrender their guns. You are also invited to help with the event on the 8th. How can we help with money collection for the gift cards? Volunteers are needed to operate chop saws and act as shepherds to help people through the process.

## Update on Truth and Reconciliation Work

Robin reported on Truth and Reconciliation work with Dr. Melchor. What has happened here in Asheville to the Black neighborhoods? We need to listen to members of the Black community who have been working on the problems for many years and have written reports. Wwe need to look at what has been done and reflect on what our Meeting could do. Who wants to stay involved? Is there a better way/time than Tuesday?
